Works at different work stations as production needs require.

Works on line where tasks vary as different product moves along line.

Maintain clean and organized work stations and surroundings in our food safe environment.

Properly documents all data required during their work day.

While performing the duties of this Job, the employee is regularly exposed to moving mechanical parts. The employee is frequently exposed to wet and/or humid conditions and extreme heat. The employee is occasionally exposed to high, precarious places and risk of electrical shock. The noise level in the work environment is usually moderate.
